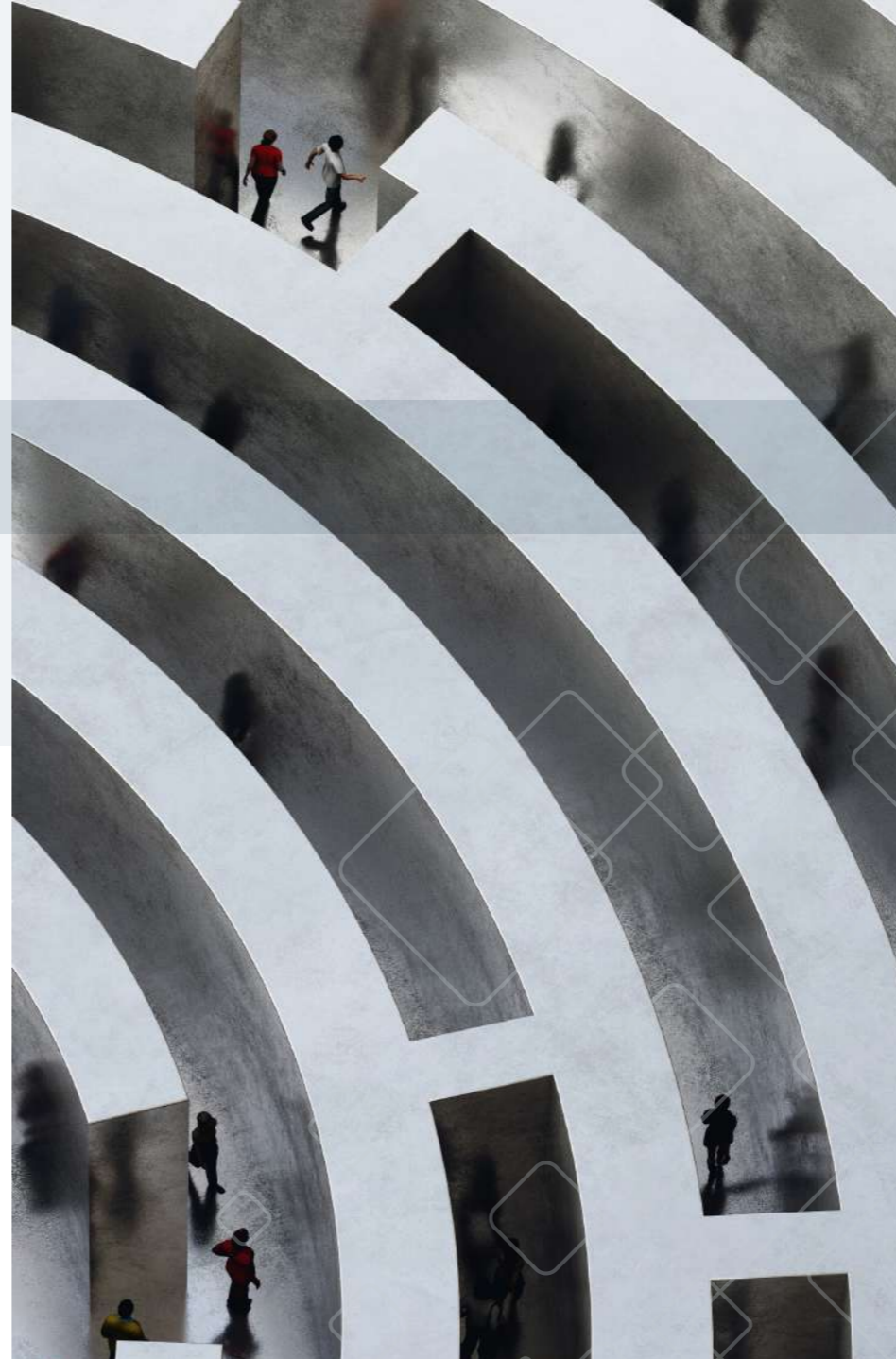
PROTECTION & ESTATE PLANNING

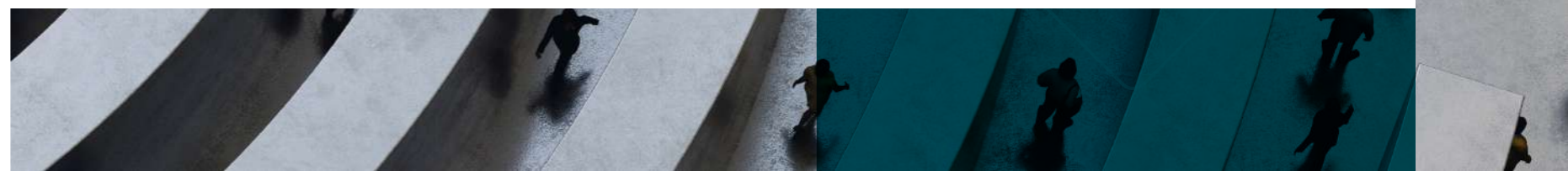
